During the post-accreditation period, the IQAC will channelize the efforts and measures of an institution towards academic excellence.

As per the guidelines, Role of IQAC is:

- IQAC is meant for planning, guiding and monitoring Quality Assurance (QA) and Quality Enhancement (QE) activities of the HEIs (Higher Education Institutions).
- IQAC may channelize and systematize the efforts and measures of an institution towards academic excellence.

GOALS

- To develop a quality system for conscious, consistent and catalytic programmed action to improve the academic and administrative performance of the *Dayanand Education Society's Dayanand College of Pharmacy*, Latur.
- To promote measures for institutional functioning towards quality enhancement through internalization of quality culture and institutionalization of best practices.

- 6. Ensuring the adequacy, maintenance and functioning of the support structure and services.


IQAC shall have the following functions:

- IQAC reviews the feedback received from the parent- teacher meetings
