- 3) To Understand OBE concept as per Vmedulife software


Description of activity:

Sir told about the meaning of OBE, Outcome-based education (OBE) is education in which an emphasis is placed on a clearly articulated idea of what students are expected to know and be able to do, that is, what skills and knowledge they need to have, when they leave the college system. Mr. Abhijeet told how to design modules for slow learners & advanced learner, identify extent of compliance of university curriculum for attaining Course Objective's (CO's), program objective (POs) & program specific objectives (PSOs). During this session he introduced staff about how to do mapping of CO's with that of PO'S in Vmedulife OBE module. He mentioned how to draw internal assessment question paper setting, model answers, question wise analysis, evaluation and its compliance, mapping of questions with the course outcome, surveys and feedback mapping. 
